# HOW TO CHOOSE AN ATTORNEY William Doverspike, Ph.D. Drdoverspike.com 770-913-0506

In my experience working on a state ethics committee for 12 years and later on a state licensing board for 12 years, I have observed that one of the biggest mistakes made by mental health professionals is when they ask other mental health professionals for legal advice. Asking a psychotherapist for legal advice can be more costly than asking an attorney for psychotherapy. It is wise to obtain consultations with respected colleagues, who can discuss clinical and ethical aspects of cases, but mental health professionals do not practice law nor can they provide privileged attorney-client consultations. Obtain legal consultation at the **first sign** of a potential problem. If you wait until a problem has developed, it is much more difficult to limit the potential damage. There is no such thing as a stupid question or unnecessary call. When choosing an attorney for a consultation or for representation in a matter related to professional practice, choose one with appropriate education, training, and experience.

## **Clinical Supervisors**

If you are under supervision by a licensed professional, then contact your supervisor, because your supervisor is ethically and legally liable for the services you provide. If your supervisor cannot address your situation, then he or she should obtain a legal consultation on your behalf. To locate an LPCA certified supervisor, contact the <u>Licensed</u> <u>Professional Counselors Association of Georgia</u>.

## **Professional Legal Service Plans**

Legal Service Plans are offered by most national and state professional associations (SPA). For psychologists, the <u>Georgia Psychological Association</u> (404-634-6272) has a Legal Services Plan for its members. For counselors, contact the <u>Licensed Professional Counselors Association</u> <u>of Georgia</u> (770-449-4547). When SPAs do not offer such plans, they are often able to recommend an attorney that is used by members of the association.

#### **Professional Liability Insurance Companies**

Particularly with respect to matters related to professional liability, contact the risk management department of your professional liability insurance company. For example, <u>The Trust Advocate</u> (800-477-1200) is affiliated with the American Psychological Association Insurance Trust ("the Trust"). Similarly, the <u>American Professional Agency</u> (800-897-0033), which insures practitioners in several mental health professional liability insurance company has an interest in protecting you so that they don't later have to defend a claim.

### **State Bar Associations**

The <u>State Bar of Georgia</u> is the governing body of the legal profession in the State of Georgia, operating under the supervision of the Supreme Court of Georgia. Membership is a condition of admission to practice law in Georgia. The State Bar of Georgia has contact information for those seeking to locate an attorney.

## **Private Attorneys**

Choose a lawyer with experience in the area about which you are seeking a consultation (e.g., administrative law, statutory laws, compliance with state and federal regulations, professional liability, representation before licensing boards). If an attorney does not reply to your initial inquiry in a timely manner, then contact someone else. Failure to return calls in a timely manner can be an early warning sign of an attorney who will not be there when really needed. The following list (in <u>alphabetical</u> <u>order</u> by last name) is not exhaustive, but simply includes local attorneys who have experience in various areas.
